# SERVICE MILEAGE RATE FOR 2025

Beginning on January 1, 2025, the standard mileage rates for the business use of a vehicle will be 70 cents per mile driven. This is up 3 cents from the 2024 RS rate. The rate for miles driven for charitable work remains at 14 cents per mile.

Meeting dates: February 28, March 14 and 28; 9:30am to 3:30pm

What we believe about God impacts all aspects of faith walk. Tina Hunt leads this class that will help us:

- A. Be able to identify four areas of current theological debate, place them in an historical context and identify appropriate ways of addressing the issues.
- B. Be able to identify four major Christian theologians, place them in an historical context and identify the contributions they have made to an understanding of the church's faith.
- C. Be able to identify the major theological streams of his/her congregation and articulate how beliefs and faith are formed in the

congregation.

- D. Be able to define the relationship between theology and practice and the relationship to a particular life issue.
- E. Be able to articulate a "theological confession of faith" that expresses the student's basic convictions regarding the Christian message.

This class is available to those interested in the ministry and to licensed ministers moving towards ordination. Ordained and Commissioned clergy can also take this class for CEU's (1.5 CEU's for attendance at all three Friday sessions) at a cost of \$25.00. And anyone can take this class for personal enrichment.

Topics covered: IRS's definitions of ministers (ministerial "status") and of ministerial work (ministerial "services"), as well as the three kinds of income ministers receive, the two kinds of taxes ministers pay, and the various ways ministers can pay those taxes during the tax year.
- 1:00pm 2:30pm EST (0.15 CEUs): **Everything You Ever Wanted to Know About Clergy Taxation, part 2.** Topics covered: Housing exclusion, parsonages and parsonage adjustments, and self-employment taxes, as well as ways to reduce total taxes.
- 3:00pm 4:00pm EST: **Completing the Clergy Tax Return.** Rev. Zeke Zacharias, pastor at Litlold Church, has a typical clergy tax return to complete. We will walk through it with him.
