


# 2025 Clergy-Spouse Retreat

# Ordination and Commissioning Renewal Information

In the Church of the Brethren, ordination credentials are reviewed every five years and will need to be renewed by the end of 2025. Clergy will be receiving a letter with all the details and forms by emails to complete the process. If you prefer paper forms, please contact the District Office. Clergy that are retired but will be active in ministry in any way over the next five years (including pulpit supply), should participate in the Ministerial Ethics training and complete CEU hours. Here are some basics:

**Background Check.** A link to a secure website will be sent to each ordained or commissioned clergy member to enter information for a background check.

### Attendance at the Ministerial Ethics Workshop.

Many completed this training either at October 26 at Ashland Dickey or October 27<sup>th</sup> at Poplar Ridge. We are so grateful to our host churches for their hospitality. There will be a makeup workshop held in the District Office on Saturday, March 29th from 10-4 pm.

Continuing Education credits. Full-time clergy must complete 5 CEU's every five years to renew ordination. This is prorated, so that at half -time pastor would need 2.5 CEU's, etc. For those that have been recently ordained, the requirements are also pro-rated.

Complete the Ordination Renewal Form. The Renewal Form has been simplified. It is one page front and back. There is an Ordination Resource Document that has additional information that you need to review as you answer the questions on the Renewal Form.

Renewal Fee of \$25. This helps cover the cost of the ethics training materials, instructor travel, and background check fee. You can mail a check or pay on-line at <a href="https://nohcob.org/renewal">https://nohcob.org/renewal</a>

**Credentialing Report Form.** This is to be filled out by the church where you are a member. This form will be sent directly to the church.

The deadline for submission of the renewal paperwork is **July 15**, **2025**. But you are encouraged to submit the documents as soon as you have completed the Ministerial Ethics Workshop and your CEU's.



Ventures in Christian Discipleship "Understanding Your Grief to Find Hope and Healing"

TUESDAYS, NOVEMBER 19 & 26, 2024 7:00 - 8:30 PM CENTRAL

Presenter: Chris Whitacre and Kathy Reid- .3 CEU credit.

The November offering from the Ventures in Christian Discipleship program at McPherson College will be "Understanding Your Grief to Find Hope and Healing," presented by Chris Whitacre and Kathy Reid. The course will be held online in two sessions: Tuesdays, November 19 and 26, at 7-8:30 p.m. Central Time.

Course Description: We all have experienced loss in varying degrees. How do we define or understand loss? How do we feel about loss? What do we believe about death and dying? How do we manage loss, if we manage it at all? This course will attempt to open doors to new learning and reflection about loss within our lives. The book "Understanding Your Grief," 2nd edition by Dr. Alan Wolfelt, will be referenced; companioning will be explored as a model for grief care; and the six needs of mourners will be highlighted.

Continuing education credit is available for \$10 per course. During the registration process, you can pay for CEUs and give an optional donation to the Ventures program. # **Clergy Mental Health Grants through Eder Financial**

The Clergy Mental Health Grant provides up to \$2500 to financial assistance for mental health expenses that insurance won't pay.

### **Your Well-being Matters**

If you or your dependents need assistance paying for mental health services, you may be eligible for financial support from the Clergy Mental Health Grant.

### **Determining Eligibility**

The grant is available to clergy who currently serve a congregation in an official capacity and their dependents living in the same household.

### **Documentation Required**

- You will need to submit a copy of the service provider's bill(s) before payments can be made.
- provider's bill(s) before payments can be made.
- You are not required to verify your income information or other expenses.

### Pastors' Housing Equity Fund is coming

The newly revised pastors' Housing Equity Fund now offers a tax-friendly option for those ministers living in parsonages who wish to build equity toward a future home purchase. Significant revisions to the fund's structure were approved by the 2024 Annual Conference and have resulted in the creation of this new investment fund option.

Whereas the former fund had unfavorable tax consequences for those invested monies donated by congregations, the soon-to-be-arriving fund offers more desirable options that are now managed by Eder Financial.


Students, clergy, and anyone who deals with clergy finances are invited to participate in this online Zoom seminar. • Learn how to prepare clergy taxes correctly and legally. • Comply with regulations while maximizing tax deductions. • Earn 0.3 CEUs - for the first 2 sessions only.

11:00am - 12:30pm EST (0.15 CEUs): Everything You Ever Wanted to Know About Clergy Taxation, part 1. Topics covered: IRS's definitions of ministers (ministerial "status") and of ministerial work (ministerial "services"), as well as the three kinds of income ministers receive, the two kinds of taxes ministers pay, and the various ways ministers can pay those taxes during the tax year.

1:00pm - 2:30pm EST (0.15 CEUs): Everything You Ever Wanted to Know About Clergy Taxation, part 2. Topics covered: Housing exclusion, parsonages and parsonage adjustments, and self-employment taxes, as well as ways to reduce total taxes.

3:00pm - 4:00pm EST: Completing the Clergy Tax Return. Rev. Zeke Zacharias, pastor at Litlold Church, has a typical clergy tax return to complete.

Registration and Cost Registration is \$40 per person (generally nonrefundable to keep fees and overhead low). Deadline to register is January 24, 2025.
